BATTLEFORDS REGIONAL SHOW IS OPEN TO ALL 4-H MEMBERS

SASKATCHEWAN 4-H LIVESTOCK SHOW RULES

Updated: September 2016

1. Beef and dairy members must select project animal(s) at least five months prior to show day.
2. Sheep and swine members must have fed, cared for and fitted their animal for at least three months prior to show day.
3. Light horse and young horse members must be responsible for the care and training of their project animal at least four months prior to show day.
4. Young horse members wishing to exhibit their project animal as a 2 & 3 –year old must have exhibited the animal as a yearling at their achievement day. Should a member's project animal become ineligible due to death, illness or injury, the member will have to begin the young horse project again with a new foal.
5. Project animals must be identified by an ear tag, tattoo, or photograph, plus name of breed and description of animal.
6. Steers and heifers that are to be shown must be born no earlier than January 1 of the previous year, e.g. 1992 show animal must be born in 1991.
7. A member showing a two-year-old or three-year-old cow must have shown the same animal in the heifer project. The cow must be shown with her natural calf of the current year at side.
8. The animal's sire determines the eligibility of an animal in breed classes.
9. Should a member's project animal become ineligible due to death or illness, the club will make a decision regarding substitution.
10. All project animals must be shown by the member at a local Achievement Day.
11. All project animals must be shown by the members at the regional show should they choose to attend. Upon extenuating circumstances, the regional show committee will be responsible for making the final decision.
12. Adults or non-4-H members will not be allowed to physically prepare or groom project animals for the show ring.
13. In showmanship and grooming classes, a member must use their own project animal.
14. Use of tranquilizers on animals is prohibited.
15. Any animal that is not properly halter broke or is unmanageable may be excused from the show and/or sale.
16. All animals in the market classes must be sold by public auction, if one is held, and become ineligible for any further 4-H shows.
17. All market animals entered in any 4-H show and sale must be castrated and dehorned.
18. A member can show and sell only one market animal, with the exception of the feedlot unit of the beef project. Feedlot unit animals cannot be sold at Achievement Days or regional shows.
19. No stallions will be allowed to show in the light horse project.
20. Members must have current year's record book available for inspection if required by the show committee.
21. Drugs and alcohol are not allowed at programs/events where members are present.
22. Cloverbud and junior members will not be penalized for assistance in the show ring.

*NOTE - 2019 Regional 4-H Show will only have Light Horse and Record Book entries.

RECORD BOOK ENTRIES RULES & REGULATIONS

REGISTRATION

1. The 2019 Light Horse Show Office.
2. Entries will be accepted on **JUNE 9, 2019** from 8:30 am to 9:00 am.
3. There is no entry fee for record book submissions.

JUDGING

1. Exhibits will be judged on **June 9, 2019** from 9:00 a.m. to 12:00 p.m.
2. Judging criteria includes:
 - i) Success in showing the public what activities are carried out to achieve the project.
 - ii) Overall appearance and quality of the project.

GENERAL

1. Registration is open to **only One top Record Book per club per age category** to all 4-H clubs that are registered in Saskatchewan.
2. **Age groups:**

CLOVER BUDS	6-8 years
JUNIOR	9-12 years
INTERMEDIATE	13-15 years
SENIORS	16-21 years
3. Ribbon & Prize money: **1st - \$10; 2nd - \$5; 3rd - \$3.** Prize money from sponsors may be gift certificates or merchandise.
4. The largest overall record book score will receive the Highest Record Book Award, Presented in Memory of Arlene Patterson.

ENTRY FEE:

All Age Categories - \$25.00 per horse

REGISTRATION:

Pre-Registration Forward entries to: Bev Flath kflath@littleloon.ca by June 1, 2019 or a \$10.00 late fee will be added. Registration will also be accepted during Show Office Hours on Sunday June 9, 2019 from 7:30-8:30am.

PRIZES:

Ribbons and prize money will be awarded as follows: 1st - \$20.00; 2nd - \$15.00; 3rd - \$10.00; 4th - \$5.00

Members must display good sportsmanship throughout the Show!

Special rules & regulations:

1. For general rules on showing, please refer to the Saskatchewan 4-H Council General Policies & Guidelines available from the Saskatchewan 4-H Office, Saskatoon, SK
2. The 4-H Light Horse Show is limited to bonafide 4-H members participating in a current 4-H Light Horse Program.
3. Age Groups of riders (as of December 31, 2018). No cross entry of age divisions allowed.
Cloverbud: 6-8 yrs
Junior: 9-12 yrs Young horse: Horse must be 3 and under
Intermediate: 13-15yrs
Senior: 16-21yrs
4. In Cloverbud Showmanship, competitors are allowed, but not required, to have a parent or responsible Intermediate or Senior member to help them by holding the end of the lead rope.
5. In all Cloverbud classes a parent, or responsible Intermediate or Senior member, must be by the barricade, so that they are immediately available to assist including Showmanship.
6. Cloverbuds will be allowed to lope the entire pattern for the gymkhana classes. A Cloverbuds may choose not to and there will not be a penalty. An adult, Intermediate or Senior member must be by the barricade.
7. **4-H members entering the Light Horse Show must have completed a current year Light Horse record book that is to be handed in at the time of entry.**
8. Exhibitors may enter only the horse(s) that must be the member's own project horse. It is the sole responsibility of the Club Leader to advise the Show Office of any cancellation of entries. A veterinary certificate is required for a horse substitution. Exhibitors who are members of two clubs may show two horses, but are only allowed to show one horse per class.
9. An exhibitor must exhibit the animal in the show ring and take exclusive charge of the animal during the show. Members must have complete control of their horse or they may be asked to leave the grounds at the decision of the Show Committee.

10. All horses must be in good health. It is recommended they be vaccinated prior to the show for the following: Equine Encephalomyelitis (sleeping sickness), Rhinopneumonitis (rhino), Influenza (flu), West Nile and tested for Equine Infectious Anemia (swamp fever).
11. Animals must be on the grounds by 8:00am Sunday June 9, 2019. Animals will be released immediately after the show.
12. Competitors are required to dress and use tack and equipment which is consistent with 4-H Rules, including long sleeve shirts. Helmets must be used in all classes if you are 18 or younger. All competitors Must wear an approved riding helmet with a secure chin strap in gymkhana events.
13. Competitors numbers must be clearly displayed on the competitors back.
14. Stallions are not permitted.
15. Only wood shavings may be used as bedding. No straw or hay can be placed in the garbage bins.
16. The use of bats, crops, quirts, whips, or ends of reins are not allowed.
17. Competitors may wear a tie down in the gymkhana classes.
18. Horses may be ridden in front of barns at a walk only. Riding in the barns is prohibited. Failure to comply with this rule will result in disqualification from the competitions.
19. **No grooming or tying of horse in alleyways of barn and no tying to trailers. (Please use the hitching rails outside of Barns #1 and #2.)**
20. It is the responsibility of the 4-H light horse Club Leader and the participant to be knowledgeable of the general and special rules of the 4-H Regional Show Committee.
21. If any dispute shall arise, the decision rests solely with the 4-H Regional Show Committee.
22. Any complaints or protests must be made in writing to the Show Office during the class before the horses leave the ring.
23. Stalls must be cleaned before leaving the Exhibition Grounds.
24. The Battlefords 4-H Regional Show Light Horse Committee, Battlefords Agriculture Society, and judges do not accept any responsibility for loss, injury, or damage to contestant, spectator and/or property.
25. Unloading and loading of horses and equipment to be done **ONLY** on South Side of barns.
26. Barn Judging will take place between 10:00am – 2pm.
27. Classes 318, 319, 320 and 321 (Extreme Trail) will be run in a separate ring from 9:30am to 2:00pm.
28. **Club leaders are requested to notify Bev Flath (kflath@littleloon.ca) by June 1, 2019 of the number of stalls required for their club and if they require panels for a stall.**

Extreme Trail Guidelines

1. Extreme Trail will be a timed event in which the horse and rider will be judged based on the partnership's ability to complete as many obstacles in a set amount of time. Obstacles may be completed in any order chosen by the rider.
2. Obstacles will vary in degree of difficulty and therefore each obstacle will be set a pre-determined point value.
3. Competitors may choose to discontinue attempting any obstacle and continue on to another of their choosing. When forfeiting an obstacle, no points will be awarded.
4. Competitor is allowed to return and retry at any time to complete any previously forfeited obstacle.
5. At the end of the time limit, the competitor's points from each successfully completed obstacle will be added.
6. Protective leg gear may be used in this class only.
7. Age Category Time Limits: **Senior** – 4 minutes; **Intermediate** – 4 minutes;
Junior- 5 minutes; **Cloverbuds** – 5 minutes
